#### KEY HIGHLIGHTS AND IMPACT NUMBERS

#### 1.SCHOOL DIGITIZATION

Digitization of education is viewed as a need of the hour in India, where many institutions are still not equipped with the right tools to make the learning environment interesting and up-to-date.

To meet the needs of a global workspace, India needs to make children (in rural Government schools also) technically enabled so that the digital skill gap is reduced and these rural students also learn with enhanced technical skills

#### 1.1 SMART CLASSROOMS AT GOVERNMENT SCHOOLS

Right To Live's mission is to bring government school students closer to technology through digital learning, using it to enhance learning methodologies and overall educational outcomes. Right To Live, in collaboration with BYJU's (Think and Learn Pvt Ltd) and CLT (Children's Lovecastles Trust), provides visually aided high-quality digital learning content to students, improving their learning outcomes and fostering a better understanding.

- The program has covered 24 Smart Classrooms across Government schools in Karnataka in 2023-24
- Corporate companies like OCWEN, Blackhawk Network, Aditi
   Consulting, & IBM have partnered for the same initiative.





## 1.2 COMPUTER LABS AT GOVERNMENT EDUCATIONAL INSTITUTIONS

Most students studying at government schools and Pre-University Colleges (PUCs) are first-generation users of digital devices and often have a significant fear of learning and using them. The setup of computer labs has helped bridge the digital and infrastructural gap between privileged private school students and underprivileged government school students. This program provides these children with access to Digital First Technologies, empowering them for the future.

- Right to Live has set up a total of 35 Computer Labs at Government educational institutions this year.
- Right To Live has partnered with Corporates like AtkinsRéalis,
   Blackhawk Network, Infogain and KPMG to set up Computer Labs in the identified colleges





#### 1.3 PROVIDING DIGITAL DEVICES TO GOVERNMENT SCHOOLS

Most of the government schools lack basic infrastructure, making it difficult for students to access modern teaching methods. By equipping classrooms with projectors and uninterrupted power supplies, this initiative helps bridge the gap between underprivileged students and their peers in private schools, fostering an engaging and tech-driven learning environment that prepares them for a digitally advanced future.



- Under the CSR initiative of the Blackhawk network, Right to Live facilitated the Digital Upgradation of a rural government school in Munduvalli village, Shivamogga district of Karnataka with Laptop, Projector, Printer and projector
- Right to Live, with the support from New England Mandaara Kannada Koota, in association with Aniketana Vedike, provided 60+ Projectors across Government schools in Gundlupet, Chamarajanagar district

#### 2. SCHOOL IMPROVEMENT

Poverty and economic deprivation is one of the main reasons for the non-participation of children at schools. Those factors demand special intervention to promote better participation of such children. Increased access to a schooling facility, has increased the number of school-going children from low-income households.

#### 2.1 TOILET CONSTRUCTION AT GOVERNMENT SCHOOL

Access to clean and hygienic toilets is a crucial factor in ensuring that students, especially girls in rural areas, can continue their education. However, many government schools in rural regions either lack sufficient toilet facilities or have none at all, putting students at significant health risk. The existing toilets are often in poor condition, with broken doors, locks, and inadequate maintenance, forcing students to use nearby open spaces for relief in the absence of proper sanitation.



- Right To Live has constructed/renovated toilets at 17 Government schools enabling students to come to the school without hinderance.
- Corporate donors such as Nasdaq, Aditi Consulting, Ahana, Vistra, and employee contribution from Microsoft has provided access to clean toilets.

#### 2.2 RENOVATION OF SCHOOLS

Through essential upgrades such as leaky roof repairs, flooring, classroom renovations, painting, fixing broken windows, doors, etc., Right To Live is revitalizing government schools to create safer, more inspiring environments that support optimal teaching and learning experiences, ultimately enhancing student success.



- Right To Live has Renovated school roofs, classrooms, painted the tornout places and other improvements at **5 Government schools**, including Government Higher Primary School, Achepalli and Government High School, Gulur at Bagepalli Taluk of Chikkaballapur.
- Corporate donor Aditi Consulting and contribution from an individual donor and the funds raised from Cisco employees Volunteering matching grant has provided access to a better school infrastructure.

#### 2.3 PROVIDING DESK-BENCHES.


Access to quality education remains a significant challenge in government schools across rural India. One of the key issues is the lack of proper infrastructure, forcing children to sit on the floor during lessons, which hinders their learning experience and overall development.



- Right to Live provided 149 desk benches to the identified schools in different districts of Karnataka.
- Right to Live with the help of various donors, such as Aditi Consulting,
   Blackhawk Network, Peepal Design and Communications Test Design
   Inc. (CTDI) provided the required infrastructure.

#### 2.4 SCIENCE LAB EQUIPMENT & STEM TINKERING LABS

Science Lab empowers the students by equipping them with cutting-edge lab equipment to foster hands-on learning and inspire curiosity beyond textbooks. Many of government schools, Pre-University Colleges (PUCs), and polytechnic colleges currently lack sufficient resources for practical classes, STEM Tinkering Lab is pioneering the creation of interactive learning spaces, ensuring students have the tools needed for practical, immersive education.



- Right to Live, in association with Tan90, has set up such STEM Tinkering
   (Natkhat) Lab at Sneha Shikshana Samsthe, Sullia, Dakshina Kannada District.
- Right to Live provided science lab equipment worth of INR 10 Lakhs to 2 Govt
  Colleges with the help of the grant provided by Corporate Donors like Novonesis
  & Infogain.

#### 2.5 PROVIDING BOOKS FOR LIBRARY

Access to quality education remains a significant challenge in government schools across rural India. One of the key issues is the lack of proper infrastructure, forcing children to sit on the floor during lessons, which hinders their learning experience and overall development.



Right to Live, provided the library books to Government High School,
 Kuguru, Bangalore with the help of the Books donated by the employees of corporate companies like Novonesis.

#### 2.6 SPORTS KIT DISTRIBUTION

The lack of sports equipment in government schools is restricting opportunities for physical activity and skill development, depriving students of the resources needed for a well-rounded education that includes physical fitness.

Addressing the issue by providing sports kits to **five government** schools in **Humnabad Taluk of Bidar District**, nurturing a culture of teamwork, discipline, and health among students.



#### 2.7 SCHOOL UNIFORM DISTRIBUTION

Ensuring that all students have appropriate attire has enabled them to pursue their educational journey with confidence, and the increased access to schooling facilities has contributed to a rise in the number of children from low-income households attending school.



- Provided school Uniforms to 294 underprivileged students in total from the Government schools of Karnataka.
- Right to Live, provided the Uniform, with the help of the grant provided by Corporate Donors like Aditi Consulting

#### 2.8 BAGS DISTRIBUTION

Poverty and economic deprivation targeted interventions require improve the participation of children low-income households education. By increasing access schooling facilities, more children from these backgrounds will have opportunity to attend school. Providing school bags will not only support these children by helping them organize their books but also motivate them to stay engaged in their education.



- Right to Live provided school bags to 887 underprivileged students from the Government schools of Karnataka.
- Right to Live provided the bags, with the help of the grant provided by Corporate Donors like Aditi Consulting, Central Data Systems (CDS)

#### 2.9 FACILITATING ACCESS TO CLEAN DRINKING WATER IN SCHOOLS

- Children from government schools in India often do not have access to clean drinking water.
- There have been many cases of children falling sick after having water from hand pumps or other contaminated water resources.
- Right to Live in association with Vistra has provided an RO water purifier to Rakum School for Blind, Devanahalli, Bangalore





#### 2.10 GREEN BOARDS

In many government schools, blackboards are often damaged, old, or have wornout paint, making them ineffective. To address this, Right To Live provides green boards, which offer better visibility and promote a more interactive learning experience



 In light of this, Right to Live, provided 4 green boards at the Government Higher Primary School, Achepalli in Bagepalli taluk of Chikkaballapura district with the support of Aditi Consulting

#### 3. HIGHER EDUCATION AND SKILL UPGRADATION

Right to Live tries to impart an education that will enhance the skills and develop the personality of the beneficiary students. Bringing out the best in unemployed youth especially women in rural and remote areas and helping them to shine with a bright future by providing the essential digital skills, is the core vision of this initiative.

## 3.1 VOCATIONAL TRAINING CENTRE — SPHURTI SKILL DEVELOPMENT CENTRE (SULLIA AND HUMNABAD)

As India's economy grows, there is an urgent need to produce technicians of international standards to meet the industry's rising demand for skilled manpower. In response to this challenge and to tackle unemployment, particularly among rural youth and women, **Right to Live** expanded its efforts by establishing a **Vocational Training Center in Humnabad, Bidar district, Karnataka**, in addition to the **Training Center already set up in Sullia, Dakshina Kannada**. These training institutes aim to equip individuals with the skills necessary to secure sustainable livelihoods and contribute to the nation's growing economy.

- This Skill Centre has been set up with the help of the generous contribution from Employees of Opteamix India Business Solutions
- In 2023-24 we had 90 students from low-income families, who were trained in Basic Computer Applications, DTP, Tally
- 80% of the Student got placed as Computer Teachers in colleges, assistants at the Grameena Janaseva Kendra (Rural welfare association), in Data Entry and Bill Generation jobs



#### 3.2 EDUCATION SCHOLARSHIP PROGRAM

The Education Scholarship Program aims to provide financial assistance to students from underprivileged communities, empowering young and talented individuals to excel in their education. This support not only helps them build financially sustainable and fulfilling futures but also encourages them to become responsible members of society.

 Right to Live did a need assessment and handed out scholarships worth INR 18L to 245 deserving bright students from low-income families.



#### 3.3 CET COACHING

Most government Pre-University Colleges (referred to as PUC) Students face challenges in accessing quality CET coaching, limiting their opportunities for higher education Students deserve equal opportunities for higher education, necessitating comprehensive CET coaching tailored to their needs.



 Right to live in collaboration with Sankalp learning solutions is bridging the gap by offering specialized CET coaching to government PU Colleges of rural Karnataka, empowering students with the knowledge and skills needed for success in their academic pursuits.

#### 3.4 SOFT SKILLS AND PRESENTATION SKILLS TRAINING

- 10 Corporate employees from IBM, engaged with over 60 students from Government Polytechnic College for Women, KR Circle, Bangalore to impart soft skills training to the latter.
- The objective of the training sessions was to develop character traits and interpersonal skills as well as complement hard skills at the workplace for these young students.



#### 3.5 CAREER GUIDANCE AND MENTORING

- This program aims to provide the right advice to high-school students regarding their higher education and career opportunities.
- Volunteers from **Cisco** lend their time, talents, and experiences to guide the 10th and 12th-grade students of the identified school.



#### 4. WELL-BEING AND HEALTHCARE

Right to Live undertakes projects aimed at improving the welfare and healthcare of the community as a whole as well as of the individuals within the community. The work done is addressing the various concerns and issues prevailing in the society.

#### 4.1 INSTALLATION OF RO WATER TREATMENT PLANTS

Bagepalli taluk in Chikkaballapur district, Karnataka, once a thriving agricultural hub, has faced serious concerns in recent years. Over 80% of the groundwater in the area is contaminated with fluoride and other dissolved salts, rendering it unfit for drinking. This contamination poses significant health risks to the local population, while also causing irreversible damage to the environment, particularly to plant life.

Right to Live has set up 3 Reverse Osmosis plants across Bagepalli in
 2023-24 with the support from Nasdaq, Trelleborg and O9 Solutions.



#### **4.2 EYE CHECK-UP CAMPS**

- Eye Camp is the most effective way of providing eye care service to a large number of people in a short time.
- It is completely free for the patients and is usually conducted with the cooperation of the local administration.
- The main objective of organizing these camps is to create awareness among people and provide services like eye care, eye check-ups and medical care.
- Right to Live, with the Healthcare partner, has conducted 5
   Community and 3 school eye-screening camps across the State In Bangalore, Humnabad and Bagepalli
- 2389 people benefitted from the 6 Eye Check-up camps, 1293
  people received spectacles, and 121 surgeries were also performed
  based on critical need with the support of Corporate Donors like
  Blackhawk, Nasdaq, and individual donor Mrs Sudha Janardhan





#### 4.3 FINANCIAL SUPPORT TO UNDERPRIVILEGED PATIENTS

- From April 2023 to March 2024, Right to
  Live received multiple applications from
  patients who were in critical need of
  medical care and support and were referred
  by individuals, partner organizations,
  corporates and hospitals
- Right To Live supported 38 patients, with the fund of INR 23,70,331 from Vistra Corporate Services, YUCCA IT Solutions and many individual donors.



## 4.4 DISTRIBUTION OF INSULIN/GLUCOMETERS FOR UNDERPRIVILEGED DIABETIC CHILDREN

- Idhayangal Charitable Trust (referred to as ICT), Right to Live's
   Healthcare partner, is a registered trust based out of Coimbatore in
   Tamil Nadu
- It serves underprivileged children suffering from insulin-requiring
   Type 1 diabetes in India.
- Right to Live, in association with this Trust, with the support from Life
   For a Child and VGS Foundation, provided Glucometers to over 1000
   children



#### **EVENTS CONDUCTED**

#### ITCS W10K MARATHON - 2023

- TCS World 10k Marathon 2023 Bangalore, is one of the most reputed marathons organized in the country.
- For the Second consecutive time, Right to Live, promoted the Digitization of Government Schools in rural areas of Karnataka and approached donors to support the same.
- It was a privilege to have Corporate Partners such as AtkinsRéalis,
   Opteamix, Ahana, Ocwen and other individual donors join hands, in May'2023, in running to make a difference in the lives of the underprivileged. Over 320 runners participated in promoting Right To Live's cause.
- Right to Live raised close to 28 lakhs on account of this event, earning the prestigious title of 'Highest Fundraising NGO'.



#### II ANNUAL WELL-WISHERS MEET

- To express heartfelt gratitude to all corporate partners, associates,

#### **III WISH TREE**

- The Wish Tree gives an opportunity to the privileged to fulfill the wishes of children from underserved sections of society.
- The annual Wishtree Distribution Event is a Right to Live initiative enabling wish fulfillment through a corporate platform.
- On this account, a Wishtree was set up at the office and the funds raised from the same have been utilized to purchase the desired 'Wishtree' items for the Students at Govt High School Gulur, Bagepalli, Chikkaballapura.
- In August 2023, employees of KPMG gathered at the identified School for the wish tree distribution event.

#### **VOLUNTEERING**

Volunteering is centered upon offering help to worthwhile causes, people in need and the wider community. Many organizations are working in the social sector while depending on the generosity of the volunteers in various aspects. Understanding the need for it as well as the sense of accomplishment, which is tied to the act of volunteering, Right to Live, around the year conducts volunteering activities for the employees of the associated Corporate Partners.

## A. PREPARATION OF MOTIVATIONAL/ INSPIRATIONAL CARDS/POSTERS

- This program aims to encourage/boost the morale of Government school students through motivational messages.
- Volunteers create cards and the Right To Live team takes printouts and hands over the hard copy of the cards to the children.
- Cisco has been the continued partner for this employeeengaging event.



#### **B. ENGAGING WITH CHILDREN AT GOVERNMENT SCHOOL**

- The volunteers spent time in person with the children

   teaching them unique skills, storytelling sessions, motivational speeches, etc.
- Employees of Cisco, KPMG, Aditi Consulting, Novonesis, Infogain and Opteamix joined hands with Right To Live for this volunteering activity.



#### C. PREPARATION OF LEARNING MODELS

- Right To Live team visited CISCO(Bellandur) for incampus volunteering activities where the volunteers joined hands with this event by preparing the Math, Science and Geography models.
- It was an enriching experience for all the involved employees(volunteers) and the prepared material was handed over to the associated Government schools of Right to Live.



#### D. CORPORATE TEAM VISITS TO VILLAGE & PROJECT SITES

- Corporates like Cisco, Nasdaq, Aditi
   Consulting and Blackhawk Network
   conducted volunteering programs
   through rural immersion at Bagepalli
   (Chikkaballapur district), on the

- Employees got a chance to see and understand the reality on the ground as well as got an opportunity to interact with the government school/PU college students in these underserved areas.




#### E. BEAUTIFYING GOVERNMENT SCHOOL WALLS
